### Discusssion:

Helen McCallum...What is the Fiscal year? Response: July 1-June 30...

Peter Matthews ... how can we reduce the \$ in the bank we have? Seems we have a lot for not doing very much. Response: Dave Western stated that we can spend it but we need people. Association could be abolished and \$ disbursed...but this is not being suggested. Constitution requires 20 board members. 8 people cannot do the work of 20.

Robert Milburn asked for review of list of items that board accomplished over the past year which Dave gladly provided.

Jacques Chesnais (Meri Squares) observer ... possible board member but needs to know more. Too many meetings.... What would he do as a director? Dave advise that Board decides how many times and when they want to meet. Directors don't have to do anything but are part of the decision process as to what the Board wants to do over the year. Directors are welcome to volunteer for other jobs to help out but don't have to.

Shirley...should we be approaching club members that serve or have served on Club boards.

Barb Englehart asked Council: Is it helpful to send out job descriptions for various available functions to see if there is anyone who is able and wants to get involved either as a board member or not as a board member, individually or shared with another person.

Teena Clarke would be willing to help.

Gerald suggested interested people attend a board meeting to see if there is something they could do.

What do clubs think is important? Should more focus be on the dancers?

### Appendix B – President's Opening Remarks

Good afternoon and welcome to the April 2019 Council of Dancers and EOSARDA's 2019 Annual General Meeting. Thank you for taking the time out of your busy schedules to attend this meeting.

Thank you to Barbara Englehart for agreeing to take Minutes for today's meeting in place of Arlo who is once again high on the seas - oh, that should be on the **high** seas.

If any of you have not yet signed in, please do so now, and if you are representing a club, please make sure that the name of your club is clearly indicated on the sign-in sheet. Please print legibly, Barbara has to try and read it later.

If you haven't already picked one up, copies of a slightly amended agenda are available on the back table. You will also find copies of the Year-to-Date Financial Report and a draft budget for 2019/2020.

We will take a fifteen minute break around 2:45 at which time we will have tea/coffee and snacks. Please resume your seats promptly at the end of the break.

As you know, this meeting usually takes place on the 3<sup>rd</sup> Sunday in April. Last year we had to reschedule the meeting for weather-related reasons - an ice storm as I recall. This year the 3<sup>rd</sup> Sunday in April was Easter Sunday. The Board was worried that we would be facing a Council high on Easter Bunny Chocolate so we thought it prudent to delay the meeting by one week. This unfortunately created a conflict with the Quinte Twirlers' Apple Blossom Dance for which I have apologized to the club. With any luck, next year we will return to our regularly scheduled activities.

To enable this Council to make decisions and to elect a new Board, a quorum of 25% of Member Clubs is required. We currently have 31 Member clubs, so a quorum is 8 clubs. Madame Registrar, can you confirm that we have enough Member Clubs present to allow us to continue?

Under EOSARDA's Constitution and By-laws:

- \$ Any registered dancer may attend and speak at this meeting,
- \$ But only Club Representatives have a vote.
- \$ Each registered club may have up to 2 representatives both of whom may vote on any issue before Council.
- \$ However, no individual Club Rep may vote more than once on any issue (you don't get two votes if you are the only rep from your club)
- \$ Directors cannot vote unless they are also Club Reps.
- \$ The Board is bound by any decision or direction issued by this Council.

When addressing Council, please keep in mind that you are not necessarily known to everyone in the hall. The Secretary in particular needs to know who you are and what club you represent. That way she will know who to blame when making up the Minutes and also who to contact if there are any questions about what was said. So, when addressing the meeting for the first time this afternoon, please clearly state your name and club affiliation before contributing to the discussion.

Those of you with prepared texts are asked to submit them to the Secretary electronically as soon as possible after the meeting.

This afternoon your Board of Directors will be reporting to you on the Board's activities over the past year.

Also this afternoon you will be voting on the Association's budget for 2019/2020 and electing a new Board of Directors to lead your Association through the next Dance Year. Seven Directors have agreed to continue to serve on the Board for another year, for which I thank them most sincerely, four Board members: Ann Davelaar, George Newton, Bob Summers and June Tripp will not be returning next year. (Bob will continue to serve as the Association's Web Master.) I want to thank them for their service to this Association. All will be missed, and all will need to be replaced.

I have been asked several times over the past few weeks what jobs need to be filled on next year's Board. That is a simple question with no easy answer.

There are of course, a few jobs that need to be filled just to keep the Board and the Association up and running. These are: President, Treasurer, Registrar and Secretary. We have identified experienced Board members who are willing to serve in these capacities for the next dance year. It will be up to the new Board to decide whether to accept these volunteers or choose someone else for these positions.

For the other Directors, their primary function will be to attend Board meetings (not all, but as many as possible) and to take part in the Board's deliberations and decision making.

The frequency, and location of Board meetings will be up to the new Board to determine.

The work the Board chooses to undertake next year will depend on:

- how many Directors there are;
- what challenges they choose to take on;
- the budget approved by Council and
- any policy directions they receive from Council

We won't know until later this afternoon, how big the 2019/2020 Board will be.

That in turn may influence what policy directions, if any, Council gives to the Board.

It will be up to the new Board to establish its work plan for next year taking into consideration:

- the Council's policy directions
- the approved budget for next year; and
- the interests and inclinations of the Directors.

For example, if the Board decides to organize one or more regional dances then someone on the Board will have to take on this responsibility. But if there are to be no regional dances, then there will be no such requirement.

That is why it is so hard to answer what seems to be a perfectly reasonable and simple question. The work to be done and the talents required to do it depend on what work the Directors collectively decide to do and the resources (human and financial) that are available to do it.

So the answer to the question is, "it all depends."

The flip side of all this is that if there is something that you really want to do that falls within the Board's mandate of promoting modern square and round dancing and encouraging its growth and advancement in Eastern Ontario, it is quite likely that the Board will let you do it.

### i) New Dancer Celebrations

Fourteen square dance clubs are participating in the 2019 New Dancer Celebrations. So far, 9 clubs have completed their Celebrations; one club will celebrate on April 30, and 4 clubs will have their Celebrations in May.

A total of 116 small envelopes were prepared. Packages of envelopes were mailed out to 4 clubs, 3 of them for the convenience of the hosts and the Visiting Directors concerned, and one because the club declined the invitation to have a Visiting Director attend its function. Eight EOSARDA Visiting Directors are participating in the ceremonies, and are expected to submit their reports.

### ii) Recognition of Major Accomplishments Certificates of Achievement

On January 12, 2019 in Carleton Place, Dave Western presented to the Mississippi Squares certificates from EOSARDA, the Ontario Square and Round Dance Federation and the Canadian Square and Round Dance Society, in recognition of their 30<sup>th</sup> annual Halfway Dance.

On April 6, Certificates of Achievement were presented to the Meri Squares from EOSARDA, the Ontario Square and Round Dance Federation and the Canadian Square and Round Dance Society, in recognition of the club's 50<sup>th</sup> Anniversary.

On that occasion, a Certificate of Achievement was also presented to John Charman on behalf of EOSARDA, in recognition of his 50 years of calling. Certificates for John have been requested from both Federation and Society.

### iii) Trillium Awards

At the Halfway Dance on January 12, 2019, on behalf of the Ontario Square and Round Dance Federation, Gerry and Jim Sawtell presented a Trillium Long Service Award to Renton and Eleanor Patterson of the Swinging Swallows Square Dance club of Pembroke. This action marked the completion of all the 2018-2019 Trillium Awards in the EOSARDA region.

Recently, Nominations for two Trillium Merit Awards and for two Trillium Long Service Awards were approved by the Board. Subsequently, Dave Western informed the Board that the Ontario Square and Round Dance Federation had confirmed receipt of all four of EOSARDA's Trillium Award Nominations for 2018-2019 within the prescribed deadline.

### Appendix H – Information Technology Committee Report eoDance Website

The eoDance website framework hasn't changed a lot in recent years. Although I'm always looking for ways to improve how the website provides information to you, most of the work is primarily focused on maintenance and updating issues such as adding or removing new clubs, correcting/changing information, adding news highlights, putting events into the calendar and linking them to the corresponding flyers on the website, etc.

### New page added

This year seemed to be a banner year for dancing in the summer months, including workshops and teaching levels. Many of these occurred almost weekly for extended periods of time.

Such offerings, lasting from a few weeks to 4 months, certainly don't qualify as an Event that could be put on the web calendar. Hence this year I created an entirely new page to list the dancing that was happening throughout the spring and summer. Since this page is only needed or used during the spring and summer period, the link to this page not in the main menus but rather is placed prominently on the Events page.

### **Domain Names**

A Domain Name is a user-friendly name or address that connects you to a computer on the internet. The computer that I'm speaking about here is the eoDance.ca, webserver, which is essentially a computer where all the website files reside.

Last year, after the SVSRDA joined EOSARDA in adopting the eoDance website as their website, we ended up with 6 ways that you can get to the website. The eoDance website can now be accessed by these domain names:

eoDance.ca eoDance.com EOSARDA.ca EOSARDA.com SVSRDA.ca SVSRDA.com

As well, the *Swing Into Spring* group has its own domain name, SwingIntoSpring.ca, that will take users directly to their information page on the eoDance website.

Having many domain names is perfectly OK if they serve a useful purpose, but we should remember that each domain name must be renewed at a cost of approximately \$30 to \$40 each year.

### Appendix J – Ontario Square and Round Dance Federation Report

The Ontario Square and Round Dance Federation had a busy year. Note our fiscal year goes from April 1<sup>st</sup> to March 31<sup>st</sup>. And our last meeting was on April 13<sup>th</sup>. Let me share things we have done for EOSARDA.

Last July "Caller School 2018" was offered In London the week previous to the Canadian Square and Round Dance Convention in London. Six Ontario Callers were recipients of Caller Bursaries including one Caller from EOSARDA, Luke Periard. Congratulations Luke and all the other recipients of Caller Bursaries. Ontario now has six new or more qualified callers. (From EOSARDA: Luke Periard; From T&D: Zoe Fingas, and Rick Gerris; and From SWOSDA: Brian MacIsaac, Merv Reid and Gail Mottashed). Funding is available at three levels for those who are interested in Calling or Cuing... from EOSARDA, from Federation, and from Society. Once approved by EOSARDA, we coordinate the rest so you end up spending very little money out of pocket to attend a school or course.

The dance season started with awarding **Trillium Awards** to three recipients in EOSARDA... one Merit and two Long Service (Merit→to the Sawtells, Long Service→to the Gilmours, and the Pattersons). These were the only Trillium Awards given in all of Ontario this fiscal year. EOSARDA is allowed to put forward four Trillium Awards each year... that is two Merit and two Long Service. Let's try to use all four every year.

Recruitment Bursaries were late in being approved this year due to circumstances beyond our control. Again EOSARDA benefitted with five of our clubs being approved → Glengarry Tartans, Grenville Gremlins, Mississippi Squares, Swinging Swallows, & Napanee Pioneers all received money towards their Recruitment Activities for the dance year 2018-19. One T&D club also received a recruitment bursary → Gateway Gliders in North Bay. As a result of EOSARDA's Recruitment Program this year, our clubs reported that EOSARDA gained 60 new dancers (Napanee Pioneers: 6 dancers, Mississippi Squares: 17, Swinging Swallows: 13, Glengarry Tartans: 8, Grenville Gremlins: 16 dancers.) Congratulations to these clubs. Another successful year!

Perhaps next Fall your club will be one of the applicants. Start collecting receipts and information on your recruitment program in June. Detailed information regarding applying for a Recruitment Bursary is on the web at squaredance.on.ca

Two items of interest: the good news is that Federation fees will remain the same in 2019-2020. But the bad news is that membership continues to slide... down from 2589 members in Ontario last year to 2252 this year, a loss of 337 dancers.

Keep the Ontario Federation in mind... we have money in our budget to help callers and clubs. We would love to share it with you. Happy Dancing.

### Appendix K – Board's 2018/2019 Work Plan

In light of on-going difficulty in recruiting a sufficient number of Directors to allow it to fulfill all of its duties, last April the Council of Dancers decided that the Association's Board of Directors would have 5 "necessary functions" for Dance Year 2018/19. These were:

- \$ publishing Square Time,
- \$ \$ \$ distributing EOSARDA Bulletins,
- maintaining the eoDance.ca website.
- registering dancers, and
- representing EOSARDA at the Ontario Square and Round Dance Federation.

Although we had a near miss on Square Time, I think that we can reasonably state that we met all five of these obligations.

Subsequent to April's Council meeting, the number of Voting Directors increased to 10 and later in the year we gained one more Director when Gerry took on the job of Square Time Editor. In light of this increase in personnel, in addition to the five priority tasks established by Council, the Board decided that it would be able to continue to administer a number of additional programs in 2018/19. The results were as follows:

### **Positive Outcomes**

- \$ The New Dancer Recruitment Subsidy Program All applications were processed and dealt with appropriately
- \$ Association participation in New Dancer Celebrations EOSARDA representatives attended most New Dancer Celebrations. Where this was not possible recognition was extended by mail.
- \$ EOSARDA's Dance Dangle Program All qualified dancers received their Dance Dangles
- \$ Processing of Trillium Award nominations Trillium Awards were presented to all of last year's successful nominees and all of this year's nominations were received by Federation prior to the cut-off date
- \$ Association recognition of major anniversaries and accomplishments All requests for Certificates of Achievement were honoured and steps were

taken to obtain certificates from Federation and Society as appropriate.

- \$ Co-sponsorship of Swing into Spring Swing-into-Swing 2018 was a great success and plans are well in hand for the
- up-coming Swing into spring 2019
- \$ A review of the number and nature of Association sponsored dances. As a result of this review, Frosty Fling 2019 went ahead as planned. The dance was a great success despite the weather. EOSARDA also co-sponsored Harvest Hop 2018 with Cornwall's Swinging Bees and is working with Pembroke's Swinging Swallows to

organize another co-sponsored dance called Shades of Autumn for next October.

### **Negative Outcomes**

- \$ The Dance Leader Training Subsidy Program
  No applications for Dance Leader Training Subsidies were received
- \$ The Publicity Network discussion group A lack of interest resulted in this initiative not proceeding as planned
- \$ Regional publicity initiatives

A great deal of foundational work was done on this project, but we were unable to proceed with a Trillium Foundation grant application as we did not meet the criteria for a grant.

### Appendix L – Co-Sponsored Dances

There was a time, not all that long ago, when EOSARDA sponsored four Regional Dances a year.

The Dance Year kicked off with the August Affair, timed to coincide with a meeting of the Ontario Federations' Board of Directors. This was followed in early October by Fall Fest, which was originally a two-day event featuring out-of-region Dance Leaders, square and round dance workshops and evening dances.

February saw Frosty Fling, a dance designed expressly for new dancers and in the spring, Jamboree celebrated the accomplishments of our newest Graduate Dancers.

All of these dances had one thing in common - they were held in Ottawa, which made sense at the time, since the bulk of the Association's membership resided in the immediate Ottawa area.

Over the years, interest in attending these Regional Dances decreased to the point where most were no longer economically feasible. The August Affair was the first to go, followed not long after by Jamboree.

Fall Fest was reduced from two days to one day and then to an afternoon event with local Callers and Cuers replacing out-of-town "celebrities". It was suspended for a couple of years, reinstated once and cancelled outright last year, leaving Frosty Fling as the sole survivor.

However, in 2012 Swing into Spring came along as a Prescott-based weekend dance event cosponsored by EOSARDA and the SVSRDA and incorporating many of the features of the original Fall Fest Dance Weekend.

Last year the Board undertook a review of the Regional Dance program. One of the first, perhaps not too surprising, results of this review was the realization that the majority of our registered dancers no longer reside in the City of Ottawa. It was felt that, at least in part, this could explain the decreased interest in attending Ottawa-based Regional Dances. So the Board decided to explore the possibility of moving some of the dances to venues outside the Ottawa envelope by co-sponsoring with a Member Dance Club.

As a Regional Dance, the co-sponsored dance would have to have the potential to attract over 100 dancers. EOSARDA would: provide seed money for the dance; underwrite any potential loss; and provide help and assistance to the co-sponsoring club as required. In return the co-sponsoring club would: plan and organize the dance in consultation with an EOSARDA contact; provide most of the human resources needed to run the dance; subject to EOSARDA approval, contract Dance Leaders for the event; and split any profits from the dance with EOSARDA on a 50/50 basis.

The first of these co-sponsored dances, the Harvest Hop, was held in Cornwall last October. Co-sponsored with the Swinging B's it was very well planned, organized and run; attracted a


reasonable number of dancers; and even made a small profit.

The next step was to try and find a club willing to co-sponsor a winter dance in Ottawa. Here we were less successful in that no co-sponsoring club was found. So EOSARDA went ahead with Frosty Fling 2019 on its own but had lots of assistance from the Lock Its, an Advanced Dance Club . Despite terrible driving conditions, the dance was a great success. It attracted a record number of new dancers who were well-supported by their fellow club members and realized a small profit for the Association.

I am pleased to advise Council that the next co-sponsored dance will be held in Pembroke this coming October. Here to speak about Shades of Autumn is the club President André Blais.

If we can collect 10 or 20 club reps. together the group could be armed with knowledge that their efforts should bring results.

### Appendix P – Posting Dances on eoDance.ca

### **Avoiding Dance Scheduling Conflicts**

Is your club hosting an Open Dance somewhere in Eastern Ontario?

Would you like to attract the maximum number of dancers possible?

Would you like to avoid having the date of your dance conflict with any other dance event in our region?

Start by taking a look at the Events Calendar posted on eoDance.ca.

Is the date that you want open or is some other event already posted on that date?

If another event is already posted, is it likely to have an impact on your club's proposed dance? If the answer to that question is "yes" then it would be wise to consider another date for your dance.

If the date is open or if the other event is unlikely to attract the same dancers as your dance, get your dance posted on the EoDance.ca calendar as soon as possible. For information as to how to get this done, see Chapter 15 of EOSARDA's Procedures Manual (http://www.eodance.ca/associations/eosarda\_procedures\_manual/chpt%2015-%20Posting%20Information%20on%20EOSARDAs%20Website.pdf)

[While you are at it, take a look at our Scheduling Conflict Policy which is set out in Chapter 26 of the Manual (http://www.eodance.ca/associations/eosarda\_procedures\_manual/chpt%2026-%20Scheduling%20Conflicts.pdf)]

Not only will this help to publicize your event, but it will also help other clubs schedule their dances since they will know which dates to avoid.

But if your dance is not listed on eoDance.ca's Calendar of Events and if, as a result, a conflicting dance is scheduled for your preferred date, please be aware that under our Scheduling Conflict Policy:

Where a Scheduling Conflict is determined to have occurred, **EOSARDA will** advertise or promote only the first scheduled dance event. This policy will apply to all advertising in Square Time, all postings on www.eoDance.ca and all EOSARDA Bulletins and any other electronic announcements.

Appendix Q – Publicity Report and associated documents not received in time for the meeting

In my November 18, 2018 report I outlined a number of reasons that could be attributing to the decline in both Clubs and membership. In summary I noted that, "what we were doing now isn't producing the desired result. Also, square dancing still seems to be branded to old-time dancing."

I then went on to recommend that EOSARDA applying for a Ontario Trillium Foundation Growth Grant. I had received approval in October to proceed with an Application for Registration in October. The Association became registered on November 30, 2018.

In the interim between starting the Registration application and the granting there of we engaged a marketing agency, on a pro-bono basis, to help develop a plan to both grow and diversify future membership.

My first contact with people at OTF was on Dec. 7, 2019 where I was quickly advised that OTF does not fund marketing programmes. Obviously this came a bit of a shock because Swinging B's from Pembroke did receive a similar grant in 2012.

Evidently guidelines had changed since then and Growth Grants now have to be, evidenced based", which was either, not evident in the guidelines or, I missed it. EOSARDA was still eligible to apply for a Seed Grant. Seed Grants are provided to help organizations experiment to find produce "evidence" to allow them to proceed with a Growth grant. However the problem was that application deadline was Feb. 6, 2019 and, information needed to support the application was extensive and not achievable within the time remaining.

I have produced some generic News article/flyers and a poster that can be adapted by any club to advertise their Open Houses and promote the benefits on Modern Square Dancing. These will be available on the eodance web site. The web master has already done some preliminary work to make this happen. Except for the pin-up posters the remaining documents are in MS Word format that can be modified to meet the individual club requirements. My personal view to promotions is that the EOSARDA clubs should have a similar look and message. Our product is fitness and wellbeing with dance being the vehicle for achieving these goals.

Remember that EOSARDA provides a promotions subsidy of 50% to a max of \$250.00 to assist clubs with their promotion campaigns. And OSARDF adds another max of \$200.00. These funds are under subscribed on an annual basis.

I have enjoyed serving on the Board for the past year but, due to personal reasons my wife and I are no longer dancing and thus did not stand for e-election.


