UPDATES since our last report of Feb 19th.

- 1. New Dancer Celebrations (Michelle & Sandy)
 - For upcoming Celebrations/Graduations, we have the following to report:
 - o 58 new dancers from 6 clubs to be 'celebrated'
 - 3 of 6 clubs asked for EOSARDA Reps to attend (Gremlins; Meri Squares; Date Squares).
 Dates are April 17 (GG); April 25 (MS); May 10 (ODS).
 - The other 3 clubs will have their New Dancer package mailed to them.
 - o The 'new' EOSARDA publicity brochure will now be included in the ND package.
 - <u>Chair Note</u> only a single EOSARDA Director volunteered to participate in ND Celebrations. That Director (Lamar) will cover 2 clubs. As a result, the CL Chair will cover the 3rd club. "Disappointing" response to say the least! [Exception Wendy V. has acknowledged that she is the caller for two of the Clubs and as such did not volunteer for those nights as an EOSARDA rep].
- 2. New Dancer Recruitment Subsidy Program (Geoff & Gavin)
 - No further applications have been received.
- 3. Dance Leader Training Subsidy Program (Ron)
 - Nothing further at this time.
- 4. **EOSARDA Dance Dangle Program** (Michelle & Sandy)
 - Chapter 24 of the Procedures Manual has been revised & posted on the website, including the new Dance Dangle Application Form!
 - Bulletin issued on Feb 27th to advise that the updated program is up & running!
- 5. Association Recognition of Major Anniversaries & Accomplishments (Helen)
 - Nothing further at this time.
- 6. Scheduling Conflict Policy (Geoff)
 - Due to the demise of SVSRDA & the most recent "conflicts" of April 29th the Procedures Manual Chapter 26 will have to be revised. That is underway and will be completed over the course of the next month or so in consultation with Arlo (bulletins), Bob (Calendar) & Gerry (Square Time) with the goal of further "minimizing" further conflicts. Geoff will be contacting all clubs with "grandfathered" dates to confirm that (1) they still will hold the indicated dance and (2) their "grandfathered" date is still valid. Although this will essentially be an "edit of C26" (& not required Board approval) it will be circulated to the Board for comment.
- 7. **Square Time Publications** (*Gerry*)
 - Bulletin just issued by Gerry calling for 'input' from clubs, leaders & dancers for the next edition, with an April 30th deadline. He hopes to have an 'online' version on the website by early May.
- 8. COMMITTEE Status for 2023-2024

Appendix D: 2023 – 2024 Budget

Budget Assumptions for budget dated 2023-03-21

1 General

Dancing will resume in September 2023. As a starting estimate, we will have 100% of 2022-23 dancers returning and paying fees.

2 Revenue

Dance revenue: There will be an EOSARDA winter dance this year.

Square Time: There will be "normal" income here.

3 Expenses

Board meetings: We pay for Zoom again for EOSARDA Board and Council of Dancers

meetings. In case we decide to have one or more in-person meetings there

is a small amount added to cover hall rental.

Publicity: Publicity will promote the 2023/24 dance year.

Website/hosting: A fixed cost unrelated to the number of dancers.

Repairs etc.: Carry forward of past amount.

Leader training: We will budget for a leader training initiative.

Square Time: We will print hard copies beginning in fall 2023.

Dance expenses: There will be an EOSARDA winter dance in 2024.
