5. New Business

5.1. Square Time

~ Gerry Johnson

5.1.1. Since Square Time is currently an on-line only publication (i.e., no printed copies are provided), production cost is minimal. The Board agreed that dance-related

advertisement in Square Time will be free of charge and that non-dance-related advertisement will be charged at the rate currently shown as "commercial".

- 5.1.2. Gerry expressed his desire to establish some sort of subscription system whereby individuals could arrange to have electronic Square Time sent directly to them.
- 5.1.3. Gerry and Arlo will confer on ways to increase readership.
- 5.1.4. The issue would be put on the agenda for Council of Dancers meeting in April.
- 5.2. Possible revisions to the Club Visit Dangle Program ~ Dave Western Gerry will complete a full policy review of the Dangle program and present an updated document to describe how dancing with one's "home club" is to be addressed.

EOSARDA position regarding old time square dancing ~ Arlo Speer With one or more old time square dance callers operating in our area, EOSARDA should have answers to whether old time square dancers and clubs are eligible for or required to hold EOSARDA membership. Apparently, old time square dance callers exist in the Perth area and in the area east of Ottawa.

Associated with the membership question is the question of eligibility for EOSARDA grants for recruitment of leader training.

Arlo has offered to serve as a point of contact should the caller operating in Kemptville reach out to EOSARDA. To this point there has been no contact, but Arlo will follow up as needed.

It's been a topsy turvy year.

For most of the winter the weather was spring-like and now it is spring, the weather is winter-like.

Through it all, we have kept on dancing, although at times it felt like we were beset by sharks on all sides:

- There were health alarms over COVID, RSV and the seasonal 'flu
- the City of Ottawa threatened to raise hall rental rates significantly
- we lost a couple of clubs
- some existing clubs are struggling to survive
- we lost a lot of dancers.

On the other hand:

- we successfully negotiated a temporary deal with the city on hall rental rates
- we replaced the old Constitution and By-laws with a new set of By-laws
- we brought the association into compliance with provincial not-for-profit legislation
- we have made a start on bringing the association into compliance with CRA requirements
- Frosty Fling was a success
- plans for Swing into Spring are well in hand
- there have been a number of successful club-sponsored Open Dances, with more to come
- the mood at all the clubs I have visited is up-beat with lots of smiles all around.

Hopefully we have begun to turn things around, but the struggle for survival is not yet over. We need to stay focussed on recruiting new dancers while working hard to retain our experienced ones and the need to find and train new Callers is becoming increasingly more urgent.

Also, while I sincerely hope that most of you will agree to serve another term of office, there is a pressing need to recruit new Board members while there is a core of experienced directors to provide the new directors with the training and nurturing, they will need to guide the association into the second quarter of the 21st Century.

To that end, prior to next month's Council of Dancers, I am asking each of you to do your very best to encourage people to volunteer to serve on the Board for 2024/25. I know that it's not an easy sell, but the need has never been more urgent.

New Dancer Recruitment Subsidy Program (Gerry) -

So far, we have received seven applications: from Mississippi Squares, Meri Squares, Square Dance Ottawa, Swinging Swallows, Glengarry Tartans, Quinty Twirlers and Grenville Gremlins. The total so far is at \$1942.48.

We have also approved & forwarded 4 applications for the OSRDF bursary.

Dance Leader Training Subsidy Program (Gavin) -

\$1,200 budgeted. I received a request from David W forwarded him by the Ontario Federation. David asked us to process this as if it had come the usual way. The request by Mary Thurston has been tentatively approved. I have spoken to her and we will process the application upon receiving receipts.

EOSARDA Dance Dangle Program (Michelle) – An article was included in the most recent Square Time. At the end of October, six applications have been received. Four applicants will receive the sliver dangle where 5 dances were completed and two applicants will receive the gold dangle where 8 dances were completed. It is good to note; that all silver dangle recipients completed more than 5 dances but did not reach 8 dances. The two gold dangle recipients exceeded 8 dances. Dangles have been ordered through SGA Signs and Trophies. The successful applicants are Diane Marsh (Mississippi Squares), Joey Walker (Mississippi Squares), Gerry Lelievre (Meri Squares), Colleen McEwan (Meri Squares), Robert Milburn (Meri Squares) and Rosie Schurr (Meri Squares). Michelle will reach out to Club Presidents regarding potential to have the Presidents present the dangle at a club dance which provides an excellent way to further promote the program. We plan to have an article in the December Square Time issue.

Association Recognition of Major Anniversaries & Accomplishments - (Gerry) -

A budget of \$100 We presented a award to Harbour Lites at the Christmas dance for their 50th anniversary. We will also be celebrating the 50th anniversary of the Grenville Gremlins in April. Reminder again that - if your Club has an anniversary coming up; or has a dancer celebrating a dancing milestone, etc., please contact Gerry (mailto:gjohnson_2003@hotmail.com).

Scheduling Conflict Policy (Gerry) - no issues so far.

Square Time Publications – (Gerry) – new issue February is on the web. Working on the April issue. We budgeted income of \$1,100, but there was no actual. We budgeted \$700. For printing and mailing, but there was no actual. I want to review the costs for advertising in Square Time. We have not been charging since we went to a web only version. I also want to look at potential new ways to get the magazine into more dancer's hands; perhaps a new subscription service.

Appendix G – Publicity

The Publicity Committee (Gloria Bateman, David Western and Lamar Mason) met in February to discuss its activities for the coming dance year.

- 1. The Publicity Committee will support whatever initiative comes from the Rural Ottawa Youth Mental Health Network
- 2. Gloria will look into the idea of supporting a postal drop for clubs. A mass mailout in a specific area through Canada Post. Dave indicated that in the past design help was available from Canada Post. Gloria will gather the information and costs and report back.
- 3. PC will remind clubs that it has materials that can be printed by them for promotional purposes so no need to reinvent.
- 4. PC will reach out to Belleville, Cornwall/Alexandria and Swinging Swallows and the Gardners to see if it can support a special event to help generate interest in their areas.
- 5. Discussion of organizing a joint event with Olde Tyme and Modern square dancing will be explored.
- 6. Gloria will also look into cost/value of generic yard signs (bulk buying) that can have club contact info added.
