Appendix B: Opening Remarks

Good afternoon and welcome to EOSARDA's Council of Dancers and Annual General Meeting for 2024. 16 of our 19 Member Clubs have registered delegates for today's meeting with 25 registered participants. Thank you for taking the time to join us this afternoon.

According to our new By-laws, a quorum for the transaction of business at a Council of Dancers meeting is 25 percent of the member clubs entitled to vote at the meeting. EOSARDA currently has 19 Voting Members, so a quorum of the membership is 5 Voting Members. Given today's attendance, I think I can safely say that we have a quorum and the meeting may proceed as scheduled.

Before we begin, Arlo will briefly review the protocols for today's Zoom meeting.

(Arlo)

Thank you Arlo

Lamar and Michelle will help me watch for hands indicating that someone wishes to address the meeting. We will do our best to make sure that all who wish to speak have the opportunity to do so, please be patient. When not speaking, please mute your microphone to help reduce background noise, but don't forget to turn it back on to speak.

We will take a 15-minute break around 2:45. Unfortunately, the downside of an on-line meeting is that you are going to have to provide your own snacks and drinks.

A brief reminder about the rules of engagement this afternoon.

Under EOSARDA's new By-laws:

- \$ Any dancer registered with EOSARDA may attend Council and speak at the meeting
- \$ Each registered club or association may designate one Voting Delegate who may vote on any issue before Council.
- \$ Only designated Voting Delegates have a vote
- \$ However, no delegate may vote more than once on any issue (you don't get two votes if you represent more than one club)
- \$ Members of EOSARDA's Board of Directors cannot vote unless they are also designated as Voting Delegates for a Member Organization
- \$ The Board is bound by any decision or direction issued by this Council.

While dancing has resumed across our region, we continue to feel the aftershocks from the pandemic. We lost two more clubs this year and another two have announced that they are unlikely to start up again in September. As Barbara will report shortly, we were reasonably successful in attracting new dancers this year, but the number of registered dancers continues to trend downward.

As we move into the third year of a return to dancing, more than ever we need to focus on growing the square and round dance movement in all corners of our region. You, our Member Clubs and Dance Leaders, are the front line in these efforts. You are both the public face of square and round dancing and the first point of contact with would-be dancers.

The Board's role is to provide you with the support and additional resources you need to deliver your programs. One of the issues we are going to discuss today is what kind of support you want from your Board. But keep in mind that our ability to deliver the help you need is limited by the number of people willing to serve on the Board.

This past year we have been working with only 8 Directors on the Board, two of whom have indicated that they will not be standing for re-election. If this association is to continue to meet the needs of you, our Member Clubs, it is essential that the departing Directors be replaced. Without sufficient human resources, there is simply no way that the Board can deliver the required services to our members. More on this shortly.

In addition to electing a new Board for 2024/254, we have a number of important business items that need to be addressed by Council. These include:

- \$ acceptance of a Financial Report for 2023/24 (the current dance year)
- \$ adoption of an Operating Budget for 2024/25 (the coming dance year)
- \$ a series of reports on the Board's activities over the past year
- \$ a discussion on the format for Square Time Print vs On-line?
- \$ a discussion on the future of your Board of Directors and
- \$ a round table discussion on best practices for attracting new dancers and new dance leaders

Lots to do and lots to talk about, so I call the meeting to order.

1. Christmas Dance and Frosty Fling Dance

Both dances were a great success:

- The Christmas dance attracted 57 people and made a profit of \$271.54.
- The Frosty Fling dance attracted 77 people and made a profit of \$286.00.

The Christmas dance was held in Prescott, which probably accounts for the lower attendance. When the Seaway Valley Association (SVSRDA) folded a short time ago, EOSARDA promised to continue holding this dance, which was a SVSRDA fixture for many years, for as long as the clubs in the SVSRDA area would support the dance. Fourteen of the attendees were from two SVSRDA club: Swinging B's and Harbour Lites. The Harbour Lites celebrated their 50th Anniversary at this dance, which encouraged many of them to attend the dance. They graciously provided two delicious cakes for the refreshment table, which was great appreciated by all!

You may wonder why the Frosty Fling, with 20 more attendees, did not make a bigger profit. That is simply because we had to pay rent for the church, when we paid nothing for the school for the Christmas dance.

We want to thank the people who volunteered to help with the various tasks that are always required to run a dance: putting up chairs and tables, arranging the refreshment table, working at the sign-in table, selling Share The Wealth tickets, handling money, greeting dancers...... In neither dance was a specific club's help requested. The word went out that volunteers were needed and more than we needed came forward to help out. It makes organizing a dance SO easy! Many, MANY thanks!!!!

Many thanks to Geoff Clarke and Wendy VanderMeulen for calling at the Christmas Dance, and to Brian Crawford and Bob Summers for calling the Frosty Fling.

2. Co-Sponsored Dances

There were no co-sponsored dances this past year. One tentative request came in, but it did not result in anything. We would encourage clubs to consider it for the next dance season.

3. Future Dances

Appendix G: Publicity Committee

Resources: The Publicity Committee has met only sporadically through the winter. After creating the new promotional brochure on square, round, and line dancing last summer for all clubs to use in their own promotional efforts, we are unsure what additional resources clubs may require. The two-sided, tri-fold brochure is available under on the eodance.ca website under "More...for clubs, Promote square and round dancing." Clubs can download the file and print when required. You can even add your club contact information at the bottom of the middle page. If there is something specific that you believe EOSARDA could produce or provide in the way of promotional materials, please let us know.

We have customized videos for use when EOSARDA is hosting a promotional event. Clubs were sent the link to Square Dance Tech (https://squaredancetech.com/) resources to obtain their own customized videos.

<u>Promotional assistance</u>: Your Publicity Committee would be willing to help with any promotional event that you are planning. Do you need to borrow a table, the EOSARDA banner, printed business cards or brochures? Do you just need some people to put on a demo or help populate your information booth or distribute your brochures? With advance notice, we can reach out to other clubs to see if there are volunteers to help. It is important that all EOSARDA clubs help each other. Smaller clubs need help sometimes from bigger ones in an effort to grow dancing in their community. Square dancers and round dancers need to work together if we are to continue and to grow. Working together we can make that happen.

<u>Rural youth</u>: EOSARDA, including the Publicity Committee, has been reaching out to the Rural Youth Mental Health Collective in rural areas around Ottawa to see if we can attract youth to our activity. We will continue to work on this initiative.

<u>Summer events</u>: So far, the Publicity Committee has not identified any major events across the region this summer where we might be able to showcase square dancing or round dancing. We need the help of all members to find these events and have the time to plan our participation. We recently saw the closing of the Bay Waves in Constance Bay and the Opeongo club in Barry's Bay. The Ottawa Valley is an area where we hope to raise our visibility by working with Swinging Swallows and former members of the Bay Waves. Cornwall is another area in which we believe we can work with existing clubs to raise awareness. If you have an event or know of a good opportunity to showcase dancing in these areas, please let us know. We would love to help.

<u>Got an idea?</u> The Publicity Committee needs your ideas and your assistance. We can only do so much "guessing" as to what clubs need. Please reach out to us at <u>publicity@eosarda.ca</u> if you have any thoughts or would like to join the team. If you have experience in marketing or graphics, we could use your expertise. Join the committee (you do not need to be a director) and help your fellow dancers.

Packages have been sent to the Glengarry Tartans and Swinging B's. Packages will be sent to Limestone Dancers and Quinte Twirlers. Napanee Pioneers are to let us know their preference. In total, we are expecting 55 new dancers on the floor!

New Dancer Recruitment Subsidy Program - (*Gerry*)

So far, we have received seven applications: from Mississippi Squares, Meri Squares, Square Dance Ottawa, Swinging Swallows, Glengarry Tartans, Quinty Twirlers and Grenville Gremlins. The total so far is at \$1942.48. We have also approved & forwarded 4 applications for the OSRDF bursary.

Dance Leader Training Subsidy Program - (Gavin)

\$1,200 budgeted. I received a request from David W forwarded him by the Ontario Federation. David asked us to process this as if it had come the usual way. The request by Mary Thurston has been tentatively approved. I have spoken to her and we will process the application upon receiving receipts. We also got a request from George Williams. Both of these potential callers will be attending Jeff Priest's caller school in April. Both of these folks dance with the most westerly area of our area.

EOSARDA Dance Dangle Program - (*Michelle*)

An article was included in the December and February Square Time Issues. We plan to continue the article in the next issue. We know that dancers are starting to chat about the dangle program at some clubs! We are making a proposal to loosen the requirements for acquiring a dangle to encourage as much travelling as possible among dancers.

Association Recognition of Major Anniversaries & Accomplishments - (Gerry)

A budget of \$100 We presented a award to Harbour Lites at the Christmas dance for their 50th anniversary. We will also be celebrating the 50th anniversary of the Grenville Gremlin's in April. Reminder again that - if your Club has an anniversary coming up; or has a dancer celebrating a dancing milestone, etc., please contact Gerry (mailto:gjohnson 2003@hotmail.com).

Scheduling Conflict Policy (*Gerry*) – no issues so far.

Square Time Publications – (*Gerry*) – new issue April is on the web. We budgeted income of \$1,100, but there was no actual. We budgeted \$700. For printing and mailing, but there was no actual. We reviewed the costs for advertising in Square Time. We will not be charging for dance related material. We will continue the current charging policy for commercial advertisements. I also want to look at potential new ways to get the magazine into more dancers' hands. I have canvassed several clubs and will convene a small task force to review the current process. I want to determine if a subscription service would help increase readership.

Appendix K: Rural Youth Outreach

The Rural Ottawa Youth Mental Health Collective is an umbrella organization consists of 13 member organizations including:

In late February, with the support of the Board and the OACA, I reached out to the Collective to offer a series of free Modern Square Dance lessons to their youth members. In making this offer, I underlined the mental and physical benefits of square dancing.

Our offer was initially well received and was followed up, about a month later, by a short Zoom meeting to flesh out our proposal. Again, there was a lot of enthusiasm on the part of the Collective's representative who promised to flag the offer to the attention of all their member organizations. I offered to meet with any of their member organizations on a no-obligation basis to discuss our proposal.

Since then — nothing.

At the Grenville Gremlins' 50th Anniversary Dance a couple of weeks ago, I made a similar offer to the Mayor of North Grenville and several of her Municipal Councilors, adding in an offer of a free dance lesson for the Council. Again the offer was very well received, with a promise to get back to me through the local club later this year.

Time will tell.

If you think that there may be an opportunity for a similar initiative in your area, contact me and we will work together to see what can be accomplished.

Appendix L: City of Ottawa Facility Rental Rates

As reported at last November's Council of Dancers, late last year City of Ottawa staff decided (without prior consultation) that our dance activities were improperly classified as being "publicly available." Therefore, the not-for-profit rate for renting City-owned facilities would no longer apply to us. This change in classification would have resulted in a four-fold increase in the hourly rental rate for the use of City-owned facilities.

At the request of the clubs impacted by this decision, an on-line meeting with City Councillors and staff from two Councillors' offices took place on November 28. No recreation staff were present. I was accompanied by Jim Kearns (Sunshine Squares), Jean-Marc Robichaud (Date Squares) and David Shackleton (Meri Squares).

Following that meeting, I received an e-mail from Councillor Devine setting out conditions for a temporary extension of the not-for-profit rate, (Appendix 1).

Early in January, while we were still working on a response to Councillor Devine's message, two clubs were advised by the City that their rental rates would be increasing effective April 2024 (Appendix 2). I immediately contacted Councillors Devine, Dudas and Brown to advise them of this turn of events. The next day, Councillor Devine advised:

- \$ There had been a breakdown in communication, and EOSARDA members do not have to pay the private rental rate.
- \$ Our mutual agreement is on hold until EOSARDA submits their confirmation to the terms we agreed to.
- \$ There will be a consultation process in 2024 (not sure when), and EOSARDA will be involved.

On January 24, 2024 I sent a formal response to Councillor Devine's original message accepting the terms and conditions as set out by the City, (Appendix 3).

On January 26, Tracey McGarry, Director, Complexes, Aquatics and Specialized Services, City of Ottawa replied

Thank you for the letter you provided in response to my email of November 28, 2023 and for agreeing to adhere to the conditions requested in order to maintain your current rental rate. I will ensure this information is shared with all of the City sites that the EOSARDA currently use.

As you know, the rental policy is currently under review and we will be going to public consultation shortly to seek feedback from our users. We look forward to your participation at that time.

At our invitation, Councillors Brown and Devine subsequently attended an afternoon dance session with Square Dance Ottawa. Both said that they had enjoyed themselves.

On March 27, at the behest of the Meri Squares, the following request was sent to Ms McGarry: As you know, as part of the agreement brokered by Councillor Devine between EOSARDA and the City of Ottawa, we undertook to advertise our dance activities as widely as possible. To help with this undertaking, would it be possible for you to designate someone on City staff with whom our clubs could work in order to have our dance information placed on various City notice boards, such as those in community centres and sports facilities, and in City newsletters?

Our request was declined. There has been no further development on this file.

Appendix 1 E-mail - Councillor Devine to David Western November 28, 2023

As discussed, we are pleased to maintain our longstanding relationship with EOSARDA and are willing to offer Not-For-Profit rates for their dance events. This, however, is contingent upon the group actively promoting and opening its events to all City of Ottawa residents, not solely its members. This commitment could take various forms, such as:

- \$ Consistently promoting events to all residents on individual club and EOSARDA's websites.
- \$ Developing and distributing printed posters/pamphlets for display on community boards at City of Ottawa buildings (subject to staff approval and space availability).
- \$ With on-site staff's permission, using an A-Frame, Sandwich board, or Chalkboard signs during events (ensuring no obstruction of traffic or emergency exits).
- \$ Using removable window decals or clings that won't damage City Property, placed strategically during events (perhaps on the door of the hall being used).
- \$ Implementing targeted social media posts or distributing flyers in public spaces visible to a broader audience beyond EOSARDA members.

In summary, the non-profit rates will be applicable for the seven Ottawa-area EOSARDA clubs currently using City of Ottawa facilities and can continue until the policy is revisited in 2024. To further that point, part of the policy revision will include public consultation with hall rental stakeholders.

Appendix 2 E-mail advising of increase in rental rates January 2024

After much discussion, you are receiving this email to advise you that there will unfortunately be increases to your rental rates effective April 2024 for all permits at Alexander Community Center & J A Dulude Arena.

To better align with the City of Ottawa's mandate and rental policy definitions the decision to charge the Private Rental rate, but at a reduced rate, has been made.

We will provide a reduced rate of \$33.86 per hour instead of the \$44.07 per hour and only implement the new rental rate as of April 2024 to allow time to adjust the fee the groups charge the participants; or any method the groups would prefer to use, to recoup the additional rental costs incurred."

Appendix 3 EOSARDA Response to City January 24, 2024

EOSARDA is pleased to note that the city is interested in maintaining the longstanding relationship between the City of Ottawa and the Association and has agreed that EOSARDA and its Member Clubs may continue to enjoy the city's not-for profit facility rental rates pending a policy review tentatively scheduled to take place later this year, subject to the group actively promoting and opening its events to all City of Ottawa residents

EOSARDA agrees to respect the afore-mentioned condition and appreciates the suggestions put forward in Councillor Devine's message, many of which are already an integral part of our advertising programs. Of course, new and innovative ideas are always welcome. Accordingly, the Association has asked all of our Member Clubs to add as many of the city's suggestions as practicable to their on-going efforts to attract residents of Ottawa to Modern Square Dancing. It should be noted however, that, among other initiatives, our on-going efforts to attract new dancers already include:

- \$ a well-established web presence at www.eodance.ca with three pages on the web site dedicated exclusively to prospective new dancers;
- \$ a substantial Social Media presence;
- \$ advertising in various print media;
- \$ occasional demo dances around the city and across the adjacent region, in various venues and at various events; and
- \$ regular free Open Houses for prospective new dancers.

Collectively EOSARDA and its Member Clubs expend significant funds every year to attract prospective new dancers. This is a significant investment for an organization that is funded solely from dancer fees. Neither the Association nor any of its Member Clubs receives financial assistance from any level of government.

I would also like to take this opportunity to confirm EOSARDA's interest in taking part in the afore-mentioned policy review.

Without prejudice to the foregoing, it appears to me that the conditions presented by city staff seem to be predicated on a continued and, in our opinion, misguided belief, that the Activity of teaching and practising Modern Square Dancing is a closed activity that is not available to "everybody". EOSARDA does not agree with that conclusion.

Staff's interpretation of "everybody" appears to only include non-dancers and does not take into account the need to accommodate Ottawa residents who are experienced square dancers. We believe that "everybody" or "all" has to be interpreted in such a way as to include those several hundred Ottawa residents who have already acquired a range of dancing skills and abilities.

Furthermore, in order to properly assess the accessibility of the Activity of teaching and practising Modern Square Dancing, the Activity should be considered in its entirety rather than by looking at one or more of its constituent parts.

In the interest of being as inclusive as possible, EOSARDA, through its Member Clubs, offers dance programs for all levels of dancers from raw beginner to experienced advanced dancers:

- \$ We have a program specifically tailored to new dancers and anyone else who wants to dance occasionally with no on-going commitment:
- \$ We have a program for new dancers who want to learn just the basics through an abbreviated 12-week teaching syllabus that, once completed, allows them to continue dancing on either a regular or intermittent basis with no further instruction required.
- We also offer a longer teaching syllabus that, in addition to introducing new dancers to \$ Modern Square Dancing, allows those who so desire, to advance through the various levels of square dancing at their own speed and to continue or remain at their current skill level for as long as they desire.

There is a program for everybody who wants to dance.

Furthermore, Modern Square Dancing welcomes:

- all ages from youth to seniors (as opposed to a youth program that, by its very nature is \$ age-restrictive).
- everyone regardless of race, creed, colour, sexual orientation or religion
- single dancers and traditional and same sex couples
- dancers who are visually impaired
- \$ \$ \$ \$ through the use of adaptive technology, dancers who are hearing impaired
- through the use of adaptive measures, those for whom no-touch dancing is necessary for religious or cultural reasons.
- \$ low income individuals through our low fee structure (\$7.00 to \$10.00 per person per night)

Ottawa has a very large geographic footprint. Offering different dance locations and a schedule that includes different dance days and different dance times further enhances the accessibility of the Activity by allowing people to choose the day, time and place that best meets their needs.

While there is always room for improvement, we believe that Modern Square dancing is one of the most accessible and open dance activities there is. Through our inter-connected network of clubs we provide a safe, fun environment for everyone who wants to dance. No one gets left out, all are welcome.

EOSARDA believes that the Activity of teaching and practising Modern Square Dancing, as currently constituted in Ottawa, fully meets all three of the published criteria for classification as not-for-profit for the purpose of renting city-owned facilities.

Appendix N: EOSARDA Achievements

EOSARDA - Where do we go from Here?

It is said that the only constant is change. This is trite but true, nothing ever stays the same.

Change is not always welcome. It can be unsettling and disturbing, interfering with our comfortable routines and creating uncertainty and anxiety. But it can also be a force for good, ensuring that new ideas come forward with new solutions for old problems.

Nowhere is this more true than with a board of directors. The lack of turnover on a board can lead to hardening of the corporate arteries. Maintaining the status quo can become the guiding principal taking precedence over all other objectives. At that point we begin to hear statements such as:

"That's not how we do it." (Perhaps true, but irrelevant.)

"We tried that once and it didn't work." (Probably not accurate since circumstances change and ideas evolve.)

To avoid this happening, it is desirable for the composition of any board to change gradually over time as some directors retire and other people take their place. But the departure of experienced board members also constitutes a loss of corporate knowledge and personal experience which can make the job more difficult for inexperienced replacements. Putting on a regional dance is a piece of cake - if you've done it multiple times - but it is a daunting task if you have not done it before and have no one to guide you.

Ideally then, any change in a board's composition should be sufficiently gradual to allow for the transfer of knowledge and experience from long-serving directors to new Board members.

But in EOSARDA the recruiting of new directors has not kept pace with the departure of experienced board members. Over the years we have seen a gradual but continual decline in the number of serving directors and, perhaps more importantly, a significant reduction in the number of clubs represented on the board.

In 2008 the were 26 Directors on the EOSARDA Board including representatives from our southwest, southeast and northwest clubs as well as representatives from the OACA and the RDTA. At the present time we have 8 Directors on the Board and no representation from any clubs outside of Ottawa. Two of our current directors are no longer active dancers and two directors, Gavin Currie and Wendy VanderMeulen are not standing for re-election this year.

Gavin has served on the board for the last 17years, Wendy has 11 years of board experience. On behalf of this Council, I would like to thank them both for their dedication and long service. Their knowledge, experience and wisdom will be missed.

Losing two experienced board members is bad enough. The situation is made worse by the fact

that only one new person has volunteered to join next year's board. This does not bode well for the on-going well-being of the association.

It negatively impacts both the Board's ability to deliver the association's programs such as New Dancer Recruitment Subsidies and Dance Leader Training Bursaries and also the transfer of knowledge to new board members. I can tell you that, from personal experience, it is not easy to take on a job where there is no corporate memory and no mentors in place to ease the transition.

Prior to this meeting of Council, we circulated a long, and frankly very impressive, list of the current board's accomplishments. Hopefully you have read it. All the items on this list have one thing in common, they require someone (or some ones) to take on the task and bring it to a successful conclusion. For purposes of oversight and accountability, some of these people need to sit on the Board of Directors, but, as Arlo is about to discuss, not all do.

Arlo:

Our by-laws call for some of the work of our association to be completed by elected directors – but not much of it!

We need at least 3 directors – new Ontario legislation recognizes that it's not always easy to get people to stand for election as directors, even though they might be able to help in some way. We need a Chair – and the Chair must be a director. We also need a Treasurer, Secretary, and Registrar – and these positions must be a director.

All other work of the association is completed by officers who are appointed by the Board but who do not need to be elected Board members.

Square Time Editor, Publicity, Club Liaison, Technology, Dances, ... everything other than Chair, Treasurer, Secretary and Registrar can be done by other volunteer officers.

- Long list of financial and other types of support and activities to promote and foster square and round dancing, support clubs in recruitment activities, encourage dancers and leaders
- Can only be accomplished with the help of volunteers both elected directors and other volunteers
- Will be unable to continue to provide these types of support without people being willing to step forward and take a lead role or lend a hand
- What EOSARDA does, whether directly for clubs or as general promotion, is geared to recruiting new dancers and retaining those we have. Without these efforts, dancers retire, clubs fold and our activity ceases

- Do you have two to four hours a month to help sustain dancing? Then there is a place for you on an EOSARDA committee

So now it's up to you. Next year's Board can do as much or as little as you want, but to do more than basic housekeeping, we need more hands on the wheel. Are you willing to step up and help to ensure the on-going vitality of square dancing in our region?

What did EOSARDA do for its member clubs this year?

Between April 2023 and April 2024, EOSARDA

- Coordinated the registration of member clubs and dancers at the regional, provincial and national levels. Remember you are all members of the Canadian Square and Round Dance Society and can dance anywhere across Canada and around the world!
- Provided \$1,745.21 to clubs to offset advertising for new dancer recruitment
- Organized the Christmas Dance (57 attendees) and the Frosty Fling (77 attendees) in support of new dancers
- Offered free attendance for new graduates at Frosty Fling
- Saw the successful completion of extensive negotiating efforts between Entandem and the Canadian Square and Round Dance Society (negotiations conducted by four EOSARDA directors) to address music royalty fees payable by callers or clubs. Efforts resulted in lower fees and simplified reporting for callers and clubs across Canada.
- Lobbied the City of Ottawa on behalf of and with the support of EOSARDA clubs directly affected by proposed major increases in fees for the rental of City of Ottawa facilities. As a result of persistent efforts by Dave Western, fees will remain at current Not-for-Profit (NFP) rates until the City's final review for all NFP organizations. The City's proposal would have increased hourly rates by about 400 percent, effectively rendering it financially impossible for most clubs renting city facilities to continue to do so. EOSARDA's efforts, with the assistance of Councillor Devine, have given clubs a reprieve for now and highlighted concerns about the City's potential approach.
- Has been working with the Rural Ottawa Youth Mental Health Collective to try to offer square dancing to youth in Ottawa's rural communities
- Developed a promotional brochure on square dancing that is available electronically to all clubs so they can avoid the expense of creating their own materials. It also has a similar brochure describing EOSARDA's activities that is provided to all graduating dancers
- Maintained its website (eodance.ca) and Facebook (facebook.com/eosarda) page that keeps clubs and dancers up to date on upcoming events and provides information on square dancing to interested members of the public
- Produced several issues of Square Time magazine that allows clubs to share their good news, announce upcoming events and recognize their callers, cuers and club members
- Issued close to 110 electronic bulletins (and counting) to keep clubs informed of dancerelated activities and events in our region and elsewhere
- Provided EOSARDA clubs with third party liability insurance at very low rates through our affiliation with the Canadian Square and Round Dance Society
- Recognized dancer achievements through the presentation of Dance Dangles to 6 dancers. Dance Dangles are a way to encourage all dancers to visit other clubs and attend dances
- Provided promotional brochures to clubs that requested them
- Recognized leadership and long service by dancers and callers and cuers by supporting club and individual nominations for Ontario Square and Round Dance Federation's Trillium Awards
- Recognized the 50th anniversary of the Harbour Lites Square Dance Club by presenting a certificate from EOSARDA

- Recognized the 50th Anniversary of the Grenville Gremlin's Square Dance Club by presenting a certificate from EOSARDA
- Welcomed 72 new dancers with welcome letters and CRSDS pins
- Supported the planning and organization of Swing into Spring
- Represented EOSARDA on the OSRDF board to ensure that the interests of Eastern Ontario clubs are taken into account when policy decisions are made at the provincial and national levels
- Drafted and implemented new bylaws to replace the previous Constitution and By-Laws that were badly outdated and no longer consistent with provincial legislation
- Brought EOSARDA into compliance with provincial not-for-profit legislation and regulations
- Is providing financial assistance to two callers-in-training

Things we offer but no one has taken us up on yet this year (there is still time!)

- Provide funding to current callers and cuers interested in improving their skills
- Co-sponsor a dance with a club to ensure no financial loss for the club
- Lots of opportunities to ask for EOSARDA support with a major promotional event in your area

And all this for the price of \$2 per club or dancer! The remainder of your \$10 club or \$8 dancer registration fee is forwarded to Ontario Federation and Canadian Society.
