There were questions about the new CallerLab proposal for square dance levels. Callers in attendance explained how the CallerLab process for approving such changes will take time so it is unlikely that any changes might be introduced for the coming dance year.

- 4. Old Business
 - 4.1. Proposed EOSARDA fees increase Appendix K Dave Western Prior to the meeting the Board circulated a proposal for a gradual increase in annual EOSARDA Membership fees, the first tranche being a \$2.00 increase for both clubs and dancers to take effect in Dance Year 2025/26.

Council did not support this proposal. After some discussion a motion was introduced from the floor, proposing a larger increase in EOSARDA fees:

MOTION: Speer/Mason that in accordance with discussion at the November Council of Dancers meeting, the EOSARDA fee be increased by \$5 so that the EOSARDA dancer and club fees would each be \$7.

After considerable discussion and many questions about the amounts of regional, provincial, and national fees, **the motion was tabled** until the EOSARDA President could contact club presidents to seek their input. The Chair deferred a vote on the new motion pending consultation with Member Clubs and Associations.

Information Notes:

- 1. Item 5.1.3 of the <u>record of the 17 November 2024 Council of Dancers meeting</u> addresses this topic.
- 2. Although the proposed motion refers to "dancer" and "club" fees, the proposed dancer rate would also apply to dance leaders and the club rate would also apply to associations.
- 3. In addition to the EOSARDA fee, EOSARDA also collects fees for the Canadian Society and the Ontario Federation.
 - a. The Canadian Society fee for dancers, dance leaders, clubs, and associations is \$5.
 - b. The Ontario Federation fee for dancers and dance leaders is \$1 and for clubs and associations is \$3.
 - c. After EOSARDA collects Society and Federation fees from our dancers, these funds do not remain with EOSARDA they are distributed to the other two organizations.
 - d. The fees for both the Ontario Federation and the Canadian Society are expected to remain unchanged for the coming dance year.
- 4. A portion of the fees going to the Canadian Society provides third party <u>liability</u> <u>insurance coverage</u> for dancers, dance leaders, clubs, club executive members, associations, and owners of facilities we use for dancing.
- 5. The following chart compares the current EOSARDA fee with the proposed \$2 and \$5 increases:

- 5.7.1. Carole Lauzon of Glengarry Tartans invited all clubs to attend the Spring Flutterwheel in Alexandria on 18 May at Glengarry Sports Palace.
- 5.7.2. Meri Squares has introduced ½ hour mentoring sessions (not by callers but by experienced dancers) before its regular dance sessions. The initiative has been successful with many experienced dancers joining the coaching periods.
- 5.7.3. Veer North went well with many visitors from other clubs, including Toronto. Unfortunately, there was less local support than had been hoped for. The next Veer North event will be in 2027, probably not over the Easter weekend.
- 5.7.4. Lamar reminded members that EOSARDA has coffee urns, water containers, and other equipment available for use by local clubs at their events.
- 5.7.5. The Apple Blossom Festival in Belleville was successful with approximately 12 squares, including 6 or 7 squares of basic dancers.

Appendix B: Opening Remarks

Good afternoon and welcome to EOSARDA's Council of Dancers and Annual Meeting for 2025. 12 of our Member Clubs and 1 association have registered delegates for today's meeting with 26 registered participants. Thank you for taking the time to join us this afternoon.

According to our By-laws, a quorum for the transaction of business at a meeting of the membership is 25 percent of our Member Clubs and Associations. EOSARDA currently has 17 Members, so a quorum of the membership is 5. Given today's attendance, I think I can safely say that we have a quorum and the meeting may proceed as scheduled.

Before we begin, Arlo will briefly review the protocols for today's Zoom meeting.

Lamar and Michelle will help me watch for hands indicating that someone wishes to address the meeting. We will do our best to make sure that all who wish to speak have the opportunity to do so, please be patient.

We will take a 15-minute break around 3:00. Unfortunately, the downside of an on-line meeting is that you are going to have to provide your own snacks and drinks.

A brief reminder about the rules of engagement this afternoon.

Under EOSARDA's new By-laws:

- \$ Any dancer registered with EOSARDA may attend Council and speak at the meeting
- \$ Each Member Club or Association may designate one Voting Delegate who may vote on any issue before Council.
- \$ Only designated Voting Delegates have a vote
- \$ No delegate may vote more than once on any issue (you don't get two votes if you represent more than one club)
- \$ Members of EOSARDA's Board of Directors cannot vote unless they are also designated as Voting Delegates for a Member Organization
- \$ The Board is bound by any decision or direction issued by this Council.

Along with the usual reports from the Chairs of our Standing Committees, this afternoon our Treasurer will provide us with an up-date on the Association's financial situation. Later this afternoon, Bob will also present Council with a draft budget for next year. That budget has been put together keeping in mind the direction the Board received from Council in November.

Also, our Publicity Chair, Lamar Mason, will be briefing Council on a new and very exciting Publicity initiative which we hope all clubs will support. More on that later this afternoon.

As always at our AGM, one of the most important tasks is the election of a new Board of Directors to steer the Association through Dance Year 2025/26.

I am pleased to announce that all of our current Directors have agreed to serve for another year and we have two new nominees for next year's Board. Good news indeed.

But two of our current Directors have expressed a desire to retire by the end of the next dance year or perhaps sooner. If the Board is to continue to meet the needs of you, our Member Clubs, additional Board members are needed now while experienced Directors are available to pass on their knowledge and experience. The work, while important, is not difficult and Board meetings usually take place on Zoom, so no travel is required. The only requirement, besides a passion for dancing, is that a Director must sit on at least one of the five standing Committees (Executive, Dance, Publicity, Club Liaison or Technology). If being a director is not your thing, then we also need a number of non-Board Volunteers to help with the day-to-day work of the Standing Committees. Interested? 1. EOSARDA Christmas Dance and Frosty Fling

Both dances were a success:

- The Christmas dance attracted 88 people (69 paid dancers/19 complimentary) and made a profit of \$350.89
- The Frosty Fling attracted 80 people (60 paid dancers/ 20 complimentary) and made a profit of \$180.58

The Christmas dance was held in Prescott at the South Grenville District Highschool. A highlight of the dance was the Trillium Award Presentation to Gerald and Marlene Casselman which attracted a number of former Harbour Lites dancers. Other special features were the caller showcase and the generous donations in both food items and cash to the South Grenville Foodbank. It should be noted that the rental for Prescott is "free" as a nonprofit organization. The breakdown of the 69 paid dancers was as follows: 2 – A2, 53 Plus, 9 Mainstream and 4 SSD/Basic and one unidentified.

The Frosty Fling was held in Ottawa at St. Marks Anglican Church. We encouraged all clubs to come with their new dancers as it was free for them! Of the 20 complimentary registrations – 14 were for SSD and /or Basic Dancers.

We wish to thank all people who volunteered to help with the various tasks that are required to run a dance: putting up chairs and tables, arranging the refreshment table, greeters, staffing the registration and the Share the Wealth desks.

Many thanks to Dave Hutchinson for calling at the Christmas Dance and for Brian Crawford and John Charman for calling at the Frosty Fling.

2. Discussion regarding Mother's Day Dance:

It was agreed to forego the Mother's Day Dance for 2025. This was due to the fact that there were a number of SSD/Basic opportunities for dancing in April and May and that the numbers of SSD/Basic dancers attending the open dances was low.

3. Future Dances

Open dances are a vital part of EOSARDA whether organized by a club or by EOSARDA. Please make every effort to support the dances by attending and be sure to bring your new dancers, where applicable. We continue to educate that the best way for new dancers to practice and improve is to attend open dances where they can enhance their learning from "new to them" callers.

- 3. Raise the visibility of EOSARDA and www.eodance.ca among member clubs

UPDATE SINCE NOVEMBER 2024

- 1. We are very pleased to have Dave and Valerie Dunham join the Publicity Committee. Their efforts with the Quinte Twirlers have resulted in attracting many new dancers locally and we are looking forward to drawing on their experience to assist across EOSARDA.
- 2. The committee's focus has been on identifying a way to work with clubs to enhance recruitment and visibility of square dancing.
- 3. The committee has identified an initiative that we have named Fair Squares. The goal is to work with clubs to identify fairs, events or locations where there is strong potential to increase the visibility of square dancing in general and to assist in recruiting for local clubs.
- 4. We have shared the Fair Squares initiative with all EOSARDA clubs. We have reached out to recruiting clubs to get their feedback and offer our support.
- 5. Wendy VanderMeulen and Lamar Mason, who administer the EOSARDA FB page, met with Carole Lauzon to learn more about boosting messages on the FB page and advertising via FB to increase visibility. A sincere thank you to Carole for sharing her knowledge with us.

Appendix I: Ottawa Area Callers Association Report

For the 2023-2024 fiscal year, we have 15 callers in good standing, of which five are new callers.

The OACA schedules six meetings per dance season, and we meet at the Alexander Community Center. Our meeting typically consists of a business session and a workshop session; the workshop portion is used to build on our shared experience and to help develop and strengthen our skills.

This past season, we have received several excellent workshop presentations from both experienced and novice callers.

In April, Dave Western attended our meeting to discuss strategies for attracting new dancers and retaining existing ones. The discussion was productive, and we valued Dave's input.

A member proposed reducing the number of meetings per dance season, and another proposed that the OACA organize a dance event that would provide opportunities for out-of-town members and newer members to call. We will be discussing these topics to see if these changes are necessary and/ or desired by the membership.

A huge Thank You to John Charman for chairing the OACA for the past two seasons.

Our next meeting is scheduled for the first Sunday in October.

Brian Crawford has agreed to chair the OACA for the 2025-2026 fiscal year.

Appendix J: Ontario Square and Round Dance Federation Report

The Ontario Square and Round Dance Federation will hold its Annual General Meeting on Saturday 03 May 2025 using Zoom. All Ontario dancers are welcome to attend. You must register to attend the meeting – to register, use this <u>link</u>. Those who have registered will receive a Zoom link to access the meeting a few days before the meeting. Anyone wishing to add items to the agenda can submit them by e-mail to <u>dan.roy1950@gmail.com</u>.

The Federation Board will meet over the summer to review the nominations submitted for this year's Trillium Awards. Award recipients will be notified after the summer meeting. All 2025 nominations from EOSARDA have been submitted.

Some clubs have reported that the facilities they rent for dancing are asking for higher levels of tenant liability insurance. In response, the Canadian Square and Round Dance Society has arranged for tenant liability insurance in the amount of \$2,000,000 (an increase from the former \$1,000,000). Registration fees for the Canadian Society and the Ontario Federation remain unchanged from 2024. Each year when EOSARDA collects its own fee, it also collects national and provincial fees on behalf of our Society and Federation. Dancers and dance leaders pay a combined \$6 to Federation and Society while clubs and associations pay a combined \$8. These fees are in addition to the current \$2 EOSARDA fee.

The Canadian Square & Round Dance Society's FESTIVAL 2026 will be held in Penticton, B.C. 15 – 18 July, 20**26**. The event will be hosted by the B.C. Square & Round Dance Federation and will operate under the name **Canadian National Square**, **Round and Clog Dance Festival**. Registration is now open – check out the <u>registration link</u>.

Appendix K – Revised EOSARDA Fees

At the November 2024 Council of Dancers there was a consensus that EOSARDA fees should be increased in Dance Year 2025/26. While several numbers were suggested, by the end of the meeting there was general agreement that the increase should up between \$4.00 and \$5.00 per year for both Member Club/Association and Dancer/Caller fees.

No increase in the fees for either the Ontario Square and Round Dance Federation or the Canadian Square and Round Dance Society is anticipated.

In preparing a draft budget for next year, the Board has taken Council's views into account and is proposing, as a first step, an increase in EOSARDA registration fees of \$2.00 per year. Under this scenario, in September of this year;

- \$ the per Member Club/ Association fee will increase from \$10.00 a year to \$12.00 with EOSARDA retaining \$4.00 and passing \$8.00 on to Federation and Society
- \$ the per Dancer/Caller fee will increase from \$8.00 per year to \$10.00 with EOSARDA retaining \$4.00 and passing \$6.00 on to Federation and Society

The Board is seeking Council's approval of the new fee schedule.
