Appendix A: Fair Square Project Report

We have confirmation from 7 clubs of their participation in Fair Squares. Two other clubs have been in communication, and we expect that we will be providing promotional materials to them. The events range from demos at local fairs to information booths at local farmers' markets. We have been flexible with the type of event because it has to work for the club and the opportunities available. As long as there is good visibility and an opportunity to interact with people to talk about square dancing and hopefully get contact information for future dancers, we are happy to support their initiatives.

We have purchased 3000 fridge magnets with the EOSARDA logo and website on them, along with 10 backpacks with the EOSARDA website that will be used as free raffle items to help collect contact information. Clubs seem enthusiastic about these promotional items. Clubs have also requested EOSARDA business cards and brochures. We will have to run another print of the EOSARDA tri-fold brochure that was developed a few years ago. We are working on logistics to deliver materials to clubs.

Two clubs inquired about including caller costs in their Fair Squares request. We have advised them to submit those fees as part of their New Dancer Recruitment claim.

We have spent about \$1000 of the \$2000 in the 2024-2025 budget. Because I am out of the country, I am unsure if I can get the cost for the brochures included in this year's budget as planned. I am still working on those logistics.

Two clubs have asked for dancers, and we are sending out an EOSARDA bulletin to get volunteers.

Other initiative

Once we have the Fair Squares Project finalized, we want to bring a second initiative to the clubs. We will offer to a generic lawn sign at a reasonable price. We are unsure how clubs will respond but we will give it a try. Cost is best if we print a generic sign rather than one with specific club information so clubs may not feel there is value. It is worth a try as this is an item that can be easily distributed throughout a club's catchment area and provides multi-season visibility.
